DEMURRAGE AND DETENTION

EXPORT

Demurrage and Detention for export container will be handled as 'Equipment Use' and 'Port Storage'. Equipment use covers the period from empty gate out ex container depot until loaded onto vessel. The Port storage covers the period from delivery of the container to the terminal (CY) until loaded onto vessel.

Equipment use applies to line supplied equipment only, Port storage applies for lines equipment and shippers own equipment.
